Terms & Conditions

1. The offer of Services provided in this agreement can be accepted by the Customer either orally or in writing by facsimile, telephone or e-mail and by payment of the deposit (if requested).
2. Selection of menu items and final numbers are preferred at least one week prior to the planned event. Late notice changes will be accommodated as best as possible.
3. Deposits for Services may be required to secure any booking and shall be deducted from the Customer's final invoice.
4. Cancellation of Services made within 2 weeks of the date of the event shall be subject to all monies previously paid being forfeited (or a cancellation fee being charged).
5. Cancellations of Services made within 24 hours of the planned booking or order shall be subject to full payment of all monies owed as per the Service Providers quote.
6. The Customer, Guarantor and Authorised Person separately acknowledge that this agreement for these Services provided is conditional upon the execution / acceptance of the guarantee and indemnity below.

Guarantee & Indemnity

- 1 In consideration of BJGP Investments Pty Ltd agreeing to provide the Services outlined in this agreement for valuable consideration, the director/s of a Customer which is a corporation (**The Guarantor/s**), by authority the Customer to the Services, hereby unconditionally guarantee the due and prompt payment of all monies owing to bj's foods – soups desserts catering by the Customer in connection with the provision of the Services to the Customer.
- 2 The Guarantor/s will:
 - (a) pay to BJGP Investments Pty Ltd the monies secured by this guarantee immediately on demand by BJGP Investments Pty Ltd;
 - (b) indemnify BJGP Investments Pty Ltd against all loss suffered as a result of:
 - (i) all or part of the money hereby secured not being recoverable; or,
 - (ii) the agreement relating to the provision of the Services not being enforceable against the Customer by reason of any factor matter whatsoever, whether or not any of the matters or facts relating thereto have or ought to have been known by the Guarantors.
- 3 This guarantee is irrevocable and is a principal obligation for the payment of the secured money.
- 4 The Guarantors' liability continues unaffected until such time as the monies hereby secured have been paid in full.
5. In the event that this agreement and the guarantee are accepted by the Customer by electronic exchange, the parties will be deemed to have executed these documents including the guarantee for payment of the secured monies when the Company accepts the offer of Services by BJGP Investments Pty Ltd by their confirmation of the order by electronic communication.
